The NSPSO is in the process of implementing a new Economic Dispatch Optimization Solution for optimizing near-real-time system dispatch. The new software requires price and quantity information for dispatchable generators to be submitted in a Price-Quantity Pair (P-Q Pair) format instead of the Hourly Load Block (HLB) format currently specified in the procedure. This change replaces references to HLBs with P-Q Pairs throughout the procedure.

The proposed changes have been made in the redline MP-11 draft.
